



Annual Watershed Conference: Sponsorship Opportunities

The Hudson River Watershed Alliance's 2025 conference theme will focus on building strong and sustainable watershed collaborations for clean water and healthy communities.

This year's Annual Watershed Conference will share case studies and strategies to support collaborative work that protects our shared waters. The conference will have two components: a virtual session via webinar (to be scheduled) and an in-person session on Tuesday, October 28 from 9 am to 3 pm at the Henry A. Wallace Center, FDR Presidential Library & Museum in Hyde Park, NY.

We anticipate strong participation from watershed communities from throughout the Hudson Valley. Over 200 people participated in our hybrid conference in 2024. We are working to make the conference as accessible as possible for participants.
